Recreation Council – Open seat

**I The minutes of the Board Meeting of February 20, 2013, were approved as written.**

**II. MOTIONS:**

**#1 Motion presented by Carl Aleccia, Building and Pools Chairman**

Move that the New Horizons-South Bay Association Board of Directors approve the amount of \$6,631.20 for leak from a pipe in the wall in building 128, units 22717 A & B Maple Ave, Torrance, CA 90505. This emergency service was performed January, 25, 2013. The vendor was Randy's Plumbing. Source of funding to come from the Building and Pools Maintenance Fund.

Seconded by Bud Brown and carried

**#2 Motion presented by Carl Aleccia, Building and Pools Chairman**

Move that the New Horizons-South Bay Association Board of Directors approve the amount of \$3507.36 for water extraction in building 125, unit 22717 A, Maple Ave., Torrance, CA 90505. This emergency service was performed January 29, 2013. The Vendor was Dry Down. Source of funding to come from the Building and Pools Maintenance Fund. Seconded by Bud Brown and carried.

Gerry Johnson noted that there was a typo: the correct building number should be 128 not 125. The Chair moved to amend Motion #2 to correct building number in question from building 125 to building 128. Seconded by Arlo Creamer and carried.

**III. BOARD OF DIRECTORS REPORT**

**Architectural** - Gary Smith's Report read by Carl Aleccia in Gary Smith's Absence.

Building 407 completed March 12, 2013. Building 408 was started for Maintenance March 18, 2013. General projects were completion of 8 touch-up work requests March 13 – 15, 2013. Some additional project work in Area 6 was done. Will continue to target Area 6 for added project work once Building 408 is completed.

**BIS** – Bud Brown: Committee discussing scanning files of old records stored in garage B. Another project is to transfer old Peachtree files to the new files. We are also considering a sub committee that will oversee contracts. The purpose of this committee will be to have a few more eyes to double check that all necessary items are covered. This will aid the Committee Chairmen, not to dilute their authority.

**Buildings & Pools** – Carl Aleccia: Wall on the north side of New Horizons separating the medical buildings from our property will be completed Friday with all City Inspections in tact.

A big problem for New Horizons is plumbing. Please be aware of any leaks in or around condos and turn off water when leaving your unit for overnight or more.

Buildings & Pools meets 4th Tuesday of month, 9:30 a.m. All are welcome.

**Civic Affairs** – Gail Standley: Committee has not met for the new term. Meetings are 2nd Friday of the month, 10:00 a.m. All are welcome.

**Clubhouse** – Gerry Johnson: Committee has not met for the new term. The new committee will discuss what to undertake for the year. Pool Furniture will be one of the projects to discuss. Meetings are 1st Tuesday of the month, 2:00 p.m.

**Condo Code Enforcement** – Arlo Creamer: Committee chair asks for everyone to keep eyes open for any safety issues. Please report with a work request. Plants and pots are issues. Meetings are 1st Monday of the month, 1:30 p.m.

**Grounds Maintenance** – Joyce Harrington, No report, absent. Committee meets 1st Monday of the Month at 11:00 a.m.

**Insurance** – Tom Kasterko: Committee has not met as new position. He will contact all people who were on this committee before for input. Tom wants to meet with Ryan Wunderliche, HUB International, and our Insurance carrier. The condominium deductible has gone down to \$10,000.00 from the previous \$25,000.00 as quoted. Committee meets 1st Monday of the month at 10:30 a.m.

**Newsletter** – Jacob Aslay – Web site still has problems but trying to correct. End of March if anyone needs a lesson on how to access, the committee will assist. Still cutting costs by going on email. If anyone wants the newsletter sent by e-mail, this will be BCC, strictly confidential, no one will have access to anyone's email. Meetings are 3rd Tuesday of the month at 10:00 a.m.

**Recreation Council** – No report, temporarily open seat.

**Resident & Orientation** – Jim Kenny: There were 41 new owners from March 2012 to March 2013 and 26 Renters. All are welcome to committee meetings. Committee meets 1st Wednesday of the month, 10:15 a.m.

Regarding department expenses paid, he has looked into the reason we are under/over budget: Administration is over budget due to the accounting fees and the audit which were all paid this month. Architectural is slightly over budget due to extra paint. Buildings and Pools is over budget in various areas. Outside services, repairs and maintenance. We had a flood in a unit that was N.H. fault, and we are repairing a wall on the north side. For more information see the current financial statement. Delinquent accounts are being collected since we contracted ALS. For two months ended 2/28/13 we are over budget approx \$15,327.00.
