This allows for the full Bora-Care treatment of all exposed wood areas in the 14 buildings scheduled for re-roofing this year (2016), and includes all exposed wood in attic areas. Vendor: Ever/Safe Exterminating Co. Source of funds: Roofing Reserve Additional Information:

OUR CURRENT RE-ROOFING PLAN INCLUDES THE BORA-CARE TREATMENT OF SHIPLAP LUMBER (USED FOR EAVES) PRIOR TO INSTALLATION. This is where the majority of termite damage has been found in the re-roofed building. Treated shiplap will be covered by the 25 year guarantee for treated wood.

Projecting extending the Roofing Reserve Plan 2 years (2023) would require a \$50 dollar monthly assessment starting in 2017. Increasing to \$55 the final two years. Roofing Reserve Plan is reviewed on an annual basis

Projecting extending the Roofing Reserve Plan 5 years (2026) would require a \$40 dollar monthly assessment starting in 2017. \$44 dollars in 2018 and \$45 dollars for the final 8 years. Roofing Reserve Plan is reviewed on an annual basis All treated areas will have a 25 year guarantee Fumigation (tenting) guarantee will be extended from 3 years to 5 years for all fully treated buildings.

NOTES ON OUR 2016 BOARD OF DIRECTOR'S ELECTION

Our Election for our new Board of Directors for 2016, will be March 8, at 7:30 pm in our Town Hall. We are going to try something different for this election. Our Board has agreed that it is time to hire a company to take care of our Election process, by mailing the ballots, and they will send each of our voting members of New Horizons, a packet just as we have always done. The packet has been put together by our Board Secretary, Kathy Lindbergh and our Election Commissioner, Joyce Higginbotham. We have compiled the packet and sent it to Ballot Box, Inc. They will print the entire number of copies and send them to our voting members. The packet will include a cover letter, the Notice of Annual Meeting, the 2016 Candidates' Bios with pictures, the secret ballot and the voting instructions. Also, included will be 2 envelopes, you place your ballot in the smaller one, and then put that envelope into the larger envelope. Be sure to sign the large envelope.

This is where our procedure is different; We will not have a voting room at the Clubhouse this year. To vote, you have three options.

- 1. Return your ballot in the large envelope via mail to Ballot Box, Inc. Ballot Box will bring your sealed ballots to the Town Hall on March 8, 2016 at 5:30 pm.
- 2. Drop off your ballot to the locked ballot box in the Clubhouse office.
- 3. Bring your ballot to the Town Hall on March 8 between 5:30 pm and 7:30 pm.
- 4. If you misplace your ballot you will have to sign an affidavit verifying that you have not voted.

Be sure to sign your name to the large return envelope. <u>Envelopes must be signed by</u> owner. Unsigned envelopes will not be counted.

We all do have time to learn how this will work, and if you have any questions please call our office, and speak to Kelly, or Joyce Higginbotham.

I promise, we will be posting this information and updated information on the Bulletin Board, and in our Newsletter. Remember our Meet the Candidates Night is February 29, 2016 at 7:30 pm in the Town Hall.
