**TIME TO CHECK FOR LEAKS**

Hi Residents,

Chuck Schaich gave a water presentation at the last Board Meeting. He left some blue pellets to help detect leaks in our toilets.

Please follow these directions: Drop two pellets in the toilet tank (there are 2 in each pack). Wait 10 minutes. If the blue color leaks into the toilet bowl, you need a new flapper for that toilet tank. The flappers can be replaced for about \$5.00 or so at Home Depot or any hardware store. These instructions are from Chuck Schaich Torrance Dept. of Public Works, Senior Analyst. Some of these pellets are available for you in the office. You can pick them up from Kelly or Carolyn. I have already ordered more from Chuck. Since we have so many units here, we may go through a lot of these pellets pretty fast.

**BOARD OF DIRECTORS' BOARD  
Meeting Minutes Wednesday, May 20, 2015**

Meeting called to order by Chairman, Bob Lombardi at 3:00 pm.

Flag Salute Welcomed new attendees to meeting.

I. Attendance: Chairman, Bob Lombardi; Secretary, Kathy Lindbergh; Treasurer, Scott Munro; Architectural Chair, Tom Kasterko; BIS Chair, Bud Brown; Buildings &

Pools Chair, Carl Aleccia; Civic Affairs Chair, Julie Dojiri; Clubhouse Chair, Pat Artman; Condo Code Chair, Linda Falzone; Grounds Maintenance, Linda Crickmore; Insurance, Joan Jones; Newsletter, presented by Paul Cohen; Recreation Council Chair, Jennifer Haymore; Resident & Orientation Chair; Barbara Helm. Absent: Vice Chair, Gary Smith.

II. Board Meeting Minutes of Wednesday, April 15, 2015 approved by Linda Falzone, 2nd by Pat Artman, All Board Members approved as written.

III. There were no Motions to approve:

IV. Presentation by Chuck Schaich and Greg Wines, Department of Public Works was introduced by Linda Crickmore. The subject: California Drought situation and How to cope with it.

Chuck Schaich introduced himself, and started out by saying this is the worst drought situation in the 40 years that he has work for the Public Works Department. He mentioned that we are in a Level 2 Water Use Requirements, that as of April 1, 2015, Governor's Executive Order calls for up to 30% water use reduction, no outside watering from 8am to 6pm, watering limited to 2 days/week; 10 minutes max/area (water station), fix all leaks, no watering 48 hours after rain. A slide show was presented and information was passed out. There are many rebate programs available. - go to -[www.bewaterwise.com](http://www.bewaterwise.com). Also this web site has tips, as well as information about local water use restrictions.

V. Board Reports:

**Architectural**, Tom Kasterko: Reported on painting building 313 and starting on building 314. His committee is gathering bids to repair and paint Clubhouse, (3) bids have been obtained; they are going to be reviewed with his committee. By next month's Workshop, they should have considered a bid to report.

**BIS**, Bud Brown: Bud's committee has conducted a review of Smart HOA and the committee decided to keep the Smart HOA until a better system is recommended.

**Buildings and Pools**, Carl Aleccia: Ant and pinhole leak problem reportedly diminished, everything is going well.

**Civic Affairs**, Julie Dojiri: Wyland Foundation Mayor's Challenge-City of Torrance won 1st place in the "water wise" challenge. Lane Closure Advisory will be in effect May 18 - June 26. One lane will be closed on Torrance Blvd. between

Maple and Madrona Avenues due to construction.

Taxi Swipe Card Workshop-Tuesday, June 16th, 9am

Torrance Transit will do a short 10-20 minute presentation followed by Q & A. This is only opened to current Taxi Riders by request of Torrance transit.

Torrance Alerts - This is a mass notification system for emergency notifications and other

information. Residents may sign up on-line or by

completing the form which is available on table next to Newsletter Office.

**Clubhouse**, Pat Artman: California Fitness Source was out to service the elliptical equipment. The alternator was old and needed to be replaced.

Also, this equipment is noisy; this should also be fixed with a new switch. Two new umbrella covers were purchased for the picnic tables. Research is being done to replace the shade netting over the picnic table area, getting quotes on this. Update next Board Meeting.

**Condo Code Enforcement**, Linda Falzone: CCE meeting was held on Monday, May 11, 2015. Since last meeting (15) work requests and/or committee observed violations were discussed. Four were Old Business, which have been resolved; nine were new ones and have also been resolved. Currently have (2) outstanding and are being investigated by the committee. Linda urges all to read the CC&Rs and Resident Rules and Regulations. She stated that she personally responds to resident's requests, she then turns them over to a committee member to follow up.

She assured all the information is kept confidential.

**Grounds Maintenance**, Linda Crickmore: Linda reported that work requests are getting done on schedule. Tony, Chuck Schaich, from the Department of Public Works and Linda are working together to save water and keep New Horizons looking beautiful. They are going to have to adjust the clocks to water some areas more and some less. Chuck Schaich stated that he did not want us to lose New Horizons grounds but wanted to follow the rules for the drought situation.

**Insurance**, Joan Jones: She reported that New Horizons is dismissed from its one legal case. The case did not affect new buyers so much but it did affect folks who wanted to refinance. New Horizons has no legal actions against us. A release letter from the lawyer was distributed to the Board Members.

She talked about extension cord plugged directly into the wall. Make sure it is a heavy duty extension cord. It can overheat if not heavy duty and may cause a fire. Two condos had extensive damage due to fire and a car accident. They are near completion. Neither of these accidents have a claim on New Horizons Insurance.

**Newsletter**, Paul Cohen, report: The Newsletter is on schedule.

**Recreation Council**, Jennifer Haymore. Recreation Council is in the process of getting ready for the Memorial Day Picnic. Starting time for the picnic is 10:00am. There are over 40 volunteers to help for this "Happy Time." We were missing software for the Boat Races but with extra effort we found it.

Jennifer read (2) unsigned letters which were placed in her box in the Board Room, telling her what she should and should not do at the picnic in a harassing way. Please join us at the next Recreation Council Committee meeting on the second Wednesday, June 10, 2015, 3:30pm.

**Resident & Orientation**, Barbara Helm: Barbara put together a paper of the procedure for Sellers and Owners of New Horizons, intending to sell or rent. There was also information about inclinators, which must be approved by the Architectural Committee. Kelly, our office administrator, ran for Barbara 550 copies. Barbara had her volunteers stuff the envelopes which were mailed out to the owners. Last month there were 2 new owners, and 1 co-renter.

**Treasurer**, Scott Munro: The overall operational performance is within budget parameters. However, maintenance repair costs have exceeded budget expectations, mostly due to leaking pipes and to a lesser extent electrical failures and problems with our aging garage doors. Our reserve budget has been impacted by the accelerated roof replacement program and the replacement of the pool solar heaters. Scott will be contacting Chairmen to review

budget performance and begin 2016 projections in the next month. There have been some questions concerning delinquent maintenance assessment payments. The total delinquency, in excess of \$20,000 is a cause for concern and the office staff has been diligent in issuing notices and following up with telephone contact. Of the total amount outstanding 65% is owed by 6 owners-1% of our total ownership and 4 of those are making payments. Where appropriate, a lien has been filed; however enforcing the lien is another matter and we have opted to seek a monetary judgment in small claims court and writing off anything above \$5,000.00. That is step 1. Then we have to collect it.

**Secretary**, Kathy Lindbergh: A new security camera, monitor and recorder have been installed in the Clubhouse. The one we had no longer worked, the ladies in the office need to see who is coming in and out of the front door, and we need to record after hours for security and safety reasons. Kelly Rupp our office administrator and Carolyn Vismara, our Bookkeeper are doing a great job, they work very well together, and help each other. They both are working with Smart HOA. There are a lot of lost and found items in the office. We put an article in the Newsletter to have people claim them; the unclaimed items will be donated.

Noted in these minutes as stated in Davis Sterling California Condo Law, that there was an Executive Session, on Tuesday May 19, 2015 at 1:00pm to discuss (2) Owner/Renter Issues

**Vice Chairman**, Gary Smith, excused absent: His report read by Kathy Lindbergh. "There was an Employee Safety Meeting: April 24, 2015 at 7:00am. 13 Employees attended, (2) videos were shown, Fire Extinguisher Safety and Real; Accidents/ Real Stories. Linda Crickmore chaired the meeting. The roofing project has been entered Phase 5. Overall a total of 29 buildings have been completed including structural repairs to all of these buildings. Next Employee Safety Meeting: May 29, 2015. 7:00am. Next Personnel Meeting: June 2, 2015, 10:15am.

**Chairman**, Bob Lombardi: Bob's comment to Architectural Chairman about Bids is that after they collect the information and are ready for contract, this then has to go through the BIS Committee for

approval. There was a problem with one rushed contract, which was not looked at by BIS which cost New Horizons money due to an overlooked clause. The lights in the Town Hall are on one switch and they all go on at the same time. The fans are on the remote controls which can be adjusted. Lastly, Bob commented that he does not want to see the Board Meetings get out of order.

Resident/Owners Comment/Questions: The question was asked how many buildings are in New Horizons, answer 121. Question was asked about financial sheet, in office upon request, did not take out for this meeting but will be at next Board Meetings. Oversight. Meeting adjourned: 4:30pm

## WATER CONSERVATION ORDINANCE

On May 5<sup>th</sup>, the City Council approved to activate Level 2 of this Ordinance. Please help save our water supply by adhering to the following:

### **Permanent Requirements at All Levels:**

- **No excessive runoff; nor washing of exterior surfaces (patios, walkways, sidewalks, etc.)**
- *No washing of vehicles with an "open hose"*
- *All water features must have re-circulating system*
- *In restaurants, drinking water provided only upon request.*
- *Lodging businesses to provide option not to launder linens daily*

### **Level 2 – Water Use Requirements**

**(Includes all of the above):**

- *Calls for up to 30% water use reduction*
- *No outside watering from 8:00 AM to 6:00 PM*
- *Watering limited to 2 days per week; 10 minute per area (watering station)*
- *Fix all leaks within 4 days*
- *Restrictions on filling & re-filling ornamentals ponds, pools, spas (guidelines are being reviewed)*

### **Irrigation Requirements 2-6-8-10**

**2 Days a week**

**6:00 PM – 8:00 AM watering times**

**10 Minutes per area (watering station)**

## WHAT KINDS OF INSURANCE SHOULD I HAVE?

Every one of us has made an excellent investment in purchasing a condo in New Horizons, a unique and beautiful place to live. The best way to protect our investment is to insure it against loss. New Horizons Association has done its part by purchasing adequate insurance to cover the Common Areas and the Buildings up to the dry wall of each condo.

The individual homeowner is obligated to purchase Personal Homeowner Insurance to cover everything within their unit's space, including wall paint, sinks, toilets, cabinetry and personal belongings.

For more detail READ THE CC&R's DATED 4/16/13 PAGES 17-20 AND PAGES 41-48. THESE PAGES TELL YOU HOW NEW HORIZONS INSURANCE COVERAGES WORK FOR YOU...THEY SPECIFICALLY STATE WHAT THE ASSOCIATION WILL PAY, AND WHAT THE HOMEOWNER HAS THE RESPONSIBILITY TO PAY.

Each Homeowner should talk to his/her Insurance Company to explore the following types of coverage:

- ◆ **PERSONAL PROPERTY COVERAGE:** Covers the replacement costs of personal belongings, furniture, clothing, bedding, lamps, carpets, etc.
- ◆ **INTERIOR STRUCTURE:** covers painting, additions, alterations, doors, windows, water heaters, sinks, toilets, cabinetry, wall lighting fixtures, etc.
- ◆ **LOSS OF USE:** Pays cost of living elsewhere during reconstruction of unit/bldg. If condo is rented out, this covers Loss of Rents.
- ◆ **LOSS ASSESSMENT:** Covers the unit owner's share of Special Assessment levied by the Association for deductible on Master Policy or if the insured loss exceeds the Master Policy limits.
- ◆ **PERSONAL LIABILITY:** Covers injuries to other people or damage to their property, if the unit owner is liable. The liability can result from acts committed by qualified family members including sporting activities (A golf ball goes through someone's window) and pets (your dog bites someone).
- ◆ **EARTHQUAKE:** New Horizons covers each building up to the dry wall of each condo. Homeowner needs to cover all items, appliances, plumbing fixtures, cabinets and personal belongings on the interior of the condo.


